C.N.C.A. LOADING CERTIFICATE FOR SHIPMENT TO ANGOLA

Any cargo with Final Destination at Republic of Angola, must be covered by the validated C.N.C.A. Loading Certificate. Any cargo not covered by the validated CNCA constitutes an offence to the regulation in force in Angola.

The rule requires that the CNCA certificate is to be applied to the authorised agent at port/country of loading. We are the authorised CNCA agent to cover the loading/shipment from China.

The CNCA fees are as follow:

One CNCA certificate will be required for each B/L.

USD 50.00 revenue per 20' container **USD 100.00** revenue per 40' container

USD 133.00 revenue per 20' Shipper's Owned Container (SOC) **USD 293.00** revenue per 40' Shipper's Owned Container (SOC)

USD 2.50 revenue per MT/CBM (whichever is greater) for LCL / vehicle / bulk / conventional cargo

** The above is the standard tariff fixed by CNCA. There will be other charges involved such as air courier charge, all bank charges, administrative fee, miscellaneous charges if any etc. Once we have the detail of your shipment, we will include all charges in our Invoice.

Document required:

- 1. Application Form (must be stamped)
- 2. B/L copy
- 3. Commercial Invoice copy
- 4. DU (DOCUMENTO ÚNICO PROVISORIO), temporary import license
- ** The above documents must be clear and readable

The application procedure is basically as follows:

- You will need to provide us the Application Form (must be stamped), B/L copy, Commercial Invoice copy and DU (DOCUMENTO ÚNICO PROVISORIO).
- Once we receive your application, we will issue an invoice for your payment arrangement. Payment is to be made to our bank account. Our invoice will show the detail of our bank account etc.
- Once full payment is received, we will prepare draft CNCA for your approval. You will need to check all details of the draft CNCA and confirm by return.
- Once draft CNCA is approved/confirmed by you, we will arrange to validate and issue the Original CNCA. Once CNCA is approved/validated it cannot be amended.
- Once the CNCA is validated we will air courier the full set (white & blue copies) of CNCA to you. You will need to forward to the Importer and shipping line.
