#### **BSC ISSUANCE**

BSC is a compulsory document for all shipments destined to Abidjan / San Pedro ports in Ivory Coast. Every B/L with an Ivorian POD must be covered by a BSC, or shall not be possible to clear the goods at destination.

### Issuance costs are as follows:

Each BL carrying cargo to Abidjan is to be covered by one B.S.C. on the base 1 BL = 1 B.S.C.

**EUR 100.00** per document fee per B/L

**EUR 36.00** per LCL container (grouping containers)

**EUR 18.00** per 20' FCL container per 40' FCL container

**EUR 23.00** per vehicle (RORO / in container)

**EUR 23.00** per 1 to 10 motor bike (RORO / in container)

\*\* In case of shipment of vehicles + other goods, two BSC will have to be issued: 1 BSC for the vehicle(s) and 1 BSC for the other goods (see above mentioned prices).

## **COMPILATION**

- 1. Documents to be sent (in PDF format):
  - Original B/L copy (not Non-Negotiable or Draft)
  - Commercial Invoice copy
  - Freight Invoice copy, if freight value not stated in the Commercial Invoice
  - Packing List copy
  - Export Custom Declaration copy
  - Certificate of Origin copy
  - Ivorian Certificate of Insurance copy (issued in Ivory Coast)
  - FDI (Fiche De Declaration A L'Importation) copy

The above documents must be clear and readable, with document reference number and date of issue, properly stamped and signed.

- 2. Applicant has to fill up the Application Form.
- 3. Foremost sends the draft BSC.

### **VALIDATION PHASE**

- 1. After check of the final draft, the applicant will give his final confirmation, in order Foremost can proceed with the process.
- 2. Validation is done by OIC Abidian, validation cannot be cancelled.
- 3. Validation is confirmed at destination after the compulsory controls and insertion of the data by the designated authorities.
- 4. After validation, Foremost forwards the final BSC (in PDF format) to the applicant. The time for obtaining the final validation can vary according to the type of controls effected at destination by OIC Abidjan.
- 5. Foremost will not be responsible of any delay in the BSC validation and insertion of the data by OIC Abidjan, also because these operations are totally out of Foremost control.
- 6. In case of documentation considered NOT compliant by OIC, the BSC will not be validated by OIC Abidjan until all proper documentations completed.
