*** IMPORTANT ***

BIETC should be validated within 15 days after shipped on board date.

Vehicles should not be over 10 years old.

Responsibility of the shipper or his representative:

- Obligation to have a BIETC in draft or prior agreement that has to be submitted to the carrier before embarkation of the cargo
- Obligation to finalize the procedure to obtain the visa within the 15 days after departure of the vessel within Asia and Oceania

The non respecting of these rules will result in a fine for the shipper or his representative.
